Privacy Policy

COLLECTION OF INFORMATION

In short: we collect information you give us

You may visit our site and participate in some of our activities without our collection of any personal information or data from you. In other circumstances, when you access our website, you may provide certain "personal identifiable information" including but not limited to your name email address, or credit card information when you register or make a purchase on our site. We may receive and store the personal information you enter on our website or give to us in any other way. Automatic Information

DISCLOSURE OF INFORMATION

In short: we do not disclose your information to third parties.

As a general rule, we do not disclose your personal information to third parties without your consent with the exception of the following circumstances:
